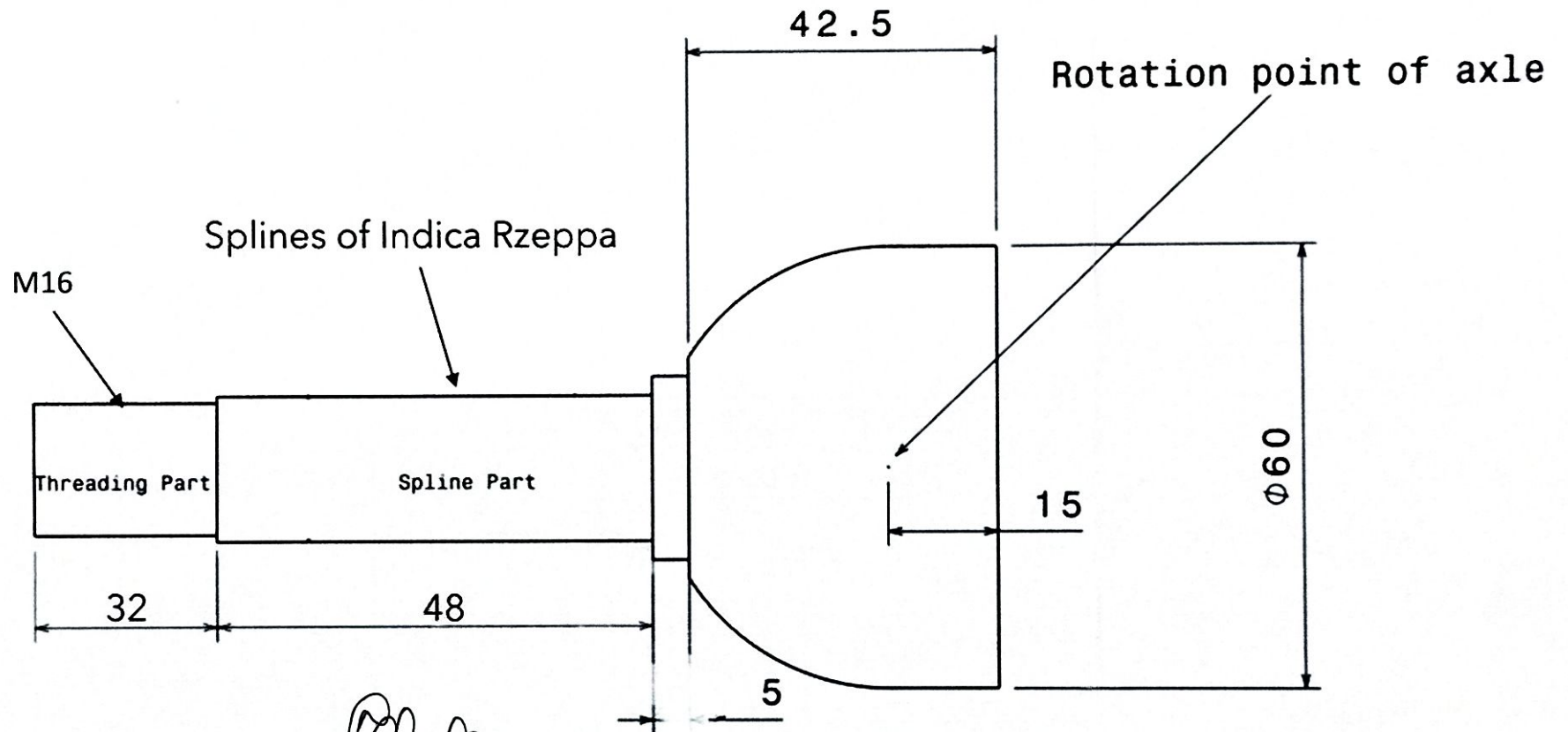
Terms and Conditions:
