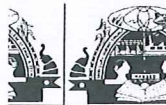
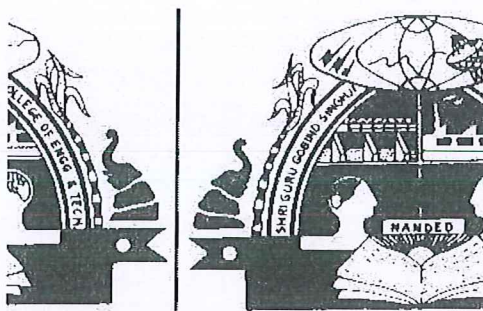

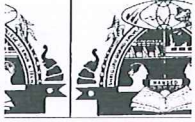

NOTICE INVITING TENDERS

Shri Guru Gobind Singhji Institute of Engineering & Technology is organizing three day national event PRAGYYA-2020 at the premises SGGs, Vishnupuri, Nanded, during the said event food is to be provided to the participants. Sealed tenders are invited from experienced and eligible contractors for **Providing food at SGGs Premises** under two bid systems Technical Bid as well as Price Bid.

A) Tender documents:-

2	Tender Cost	Rs. 200/- + 18 %GST, (Rupees Two Hundred + 18% GST) (Non-refundable). Contractor has to remit the tender cost online https://www.onlinesbi.com/prelogin/icollecthome.htm
3	EMD	Tender should be accompanied with an Earnest Money Deposit (EMD) of Rs.2,000/- (Rupees Two thousand only). Contractor has to remit the E.M.D. online https://www.onlinesbi.com/prelogin/icollecthome.htm
4	Security Deposit	<ol style="list-style-type: none">1. The Successful tenderer whose tender is accepted will have to pay 5% of tender amount towards the security deposit.2. The Security deposit less any amounts due regarding penalties shall be returned to the agency after end of the contract without interest on amount and subject to officer in-charge certifying that no liability attaches to the Contractor/agency.3. The security deposit will liable to forfeited in the event of non-fulfillment of terms and conditions by the tenderer. Any loss from the bad services of the Contractor as determined by the authority is recoverable for security deposit.

B) Submission of Tender:-

The sealed envelopes superscribed with “Providing food for Pragyaa 2022” containing two separate envelopes for Technical & Price bid addressed to DIRECTOR, Shri Guru Gobind Singhji Institute of Engineering & Technology, Vishnupuri, Nanded, can be submitted by 22-04-2022 up to 2.30 PM.

C) Opening of Tender :-

1. Technical Bid: - Technical bid will be opened on 22.04.2022 at 3.00 p.m. In the office of Dean, Student’s Affair, SGGsIE&T in the presence of the authorized representatives of tenderers.
2. Price Bid: - Opening date and time of Price bid will be communicated to the selected qualified bidders after technical bid evaluation.

D) Details of Tender:-

Further details on this tender are explained in General Terms and Conditions.

General Terms & Conditions

1. Definition:

- 1.1 The "Institute" shall mean the Premises of "Shri Guru Gobind Singhji Institute of Engineering & Technology, Vishnupuri, Nanded-431606".
- 1.2 The "Contractor" shall mean successful bidder and shall include their legal representatives.
- 1.3 The "Officer in-Charge" shall mean the officer of the centre, designated to supervise related work.

2. Eligibility Criteria:

The bidder i.e. individual / company / Firm / Organization shall submit the documentary evidences to meet eligibility criteria as under;

- 2.1 Registration with statutory bodies like Shop Act, GST is mandatory. Self attested copies of PAN and TIN is to be enclosed.

3. Earnest Money Deposit

- 3.1 Any type of exemption for E.M.D. will not be given or considered.
- 3.2 The tenders not accompanied by an earnest money deposit shall be treated as "non-responsive" and may be rejected.
- 3.3 In case of successful bidder the EMD shall be kept as security deposit without interest till the validity of supply order. Earnest Money Deposit of unsuccessful bidder shall be refunded without interest.
- 3.4 The EMD will be forfeited in following cases:
 - I. If the bidder fails to accept the order based on his offer.
 - II. If the bidder fails to supply in compliance to specification given in Annexure-1 as per the terms and conditions attached
- 3.5 The tender document is non-transferable

4. **Submission & Opening of tenders: -**

Tender complete in all respect shall be submitted to the Director, at Institute by 22.04.2022 up to 2.30 pm. Any cutting/over writing etc. in the tender must be signed by authorized signatory. The rates mentioned shall not be overwritten. The financial figures in commercial bid shall always be both in figures and words. In case of any discrepancy in figures and words, the amount written in words shall be considered.

4.1 **Envelope- I (Technical Bid)**

4.1.1 This envelope should contain receipt tender cost and EMD.

4.1.2 Eligibility Criteria documents fulfilling clause 2 of the tender mentioned above.

4.2 **Envelope- II (Price Bid):**

4.2.1 General Terms & Conditions of the tender to be duly signed & stamped.

4.2.2 This envelope shall contain **Price bid** as per **schedule 'B'** enclosed with the tender.

5. **Validity**

Validity of tender: The tender shall remain valid for a period of 30 days from the date of opening of Technical Bids.

Validity of Rates: Rates shall remain unchanged for the period of six Months.

6. **SCOPE OF WORK**

6.1	The scope of work shall include "Serving food as per Annexure-1" at Institute.
6.2	The institute officer in-charge responsible for the assigned work will conduct inspection of prepared food.
6.3	The quality of food can be reviewed during course of serving food. In case of quality & quantity of food is not as per requirement up to the last person availing the food, the contract will be penalized. Penalty will be in the form reduced rate. Regarding the reduced rate the decision of Director will be final and binding to both the parties.
6.4	Bidder has to supply food court tent of size 15' x 75' with sidings and required buffet tables with cover on all three days. No separate cost will be paid to tent and buffet tables.

7 GENERAL CONDITIONS FOR CATERING

7.1	The food has to be prepared in clean, hygienic and safe conditions as per the menu.
7.2	The rates quoted should clearly mention the basic rate plus taxes.
7.3	Payment of the bill will be made through Account Payee Cheque /RTGS after deduction of applicable Taxes
7.4	The contractor should submit their best price while submitting their bids itself and they will not be allowed to revise the price any time thereafter.
7.5	It shall be the Contractors responsibility to protect against accidents on the works . He should protect all his worker from fire or any type of accident. Its whole responsibility of contractor to compensate his worker .
7.6	DIRECTOR of the Institute reserves the right to reject one or all of the bids during any stage of above tender process without assigning any reasons.
	In the event of any dispute the legal matter shall be subjected to the jurisdiction of Nanded Court only
