**Topic:** A meeting proposed by Dean Student Activities to discuss the queries and feedback regarding the new guidelines from Government and generalized issues.

**Agenda:** Sports Achievements, FY & DSY Admissions, Offline Response, Exam Assistance, TY & B.Tech Hostel Vacating Process, and other topics included.

**Points discussed:**

1)The Hon'ble Director discussed the EGRC and its future decisions in order to keep the Examination Process Smooth and that the will get easy for Faculty.

2)Dean Student Activities informed SIC members about the great achievements of SGGS students in ICT(Inter College Tournaments) in sports of Table Tennis, Lawn Tennis, Kabbadi, Football, and Other Sports and wished them for the IUT.

3)Third Year and Final Year Students appealed for an extension in the date of Vacating the Hostel rooms which were allotted to them in the academic year 2019-20 the point is kept for discussion and Prof.R.S.Holambe also told some tentative solutions to the students.

4)Regarding the Placement of Core Branches of Final Year: The Training and Placement Cell was requested to keep the process transparent so that the students get to know the efforts taken and their future scope as observed most placement is from CSE and IT background students.

5)Mr. Yogesh Tabjula K from Final Year raised a point of having an Internal Grievance Committee inside the SIC, some points were discussed by Director Sir and Dean SA, and the point is kept under discussion.

6)The Charge for bus services is final i.e. 10,000 per year and the bus will be started if the response is good(for now only 70 responses were collected so buses cannot be started in this case).

7)The End Term Examination is scheduled for the end of this month and will be held online. The decision regarding the next Semester(Physical or Online or Blended) is not taken yet as the Omicron Variant has rising cases for now no decision has been taken by Government as soon as Institute receives SOP they will be implemented and informed to students. (Applied for Hostel Reopening, Exams and Other things as well) For now, Institute will be opened as per norms told earlier.

8) Regarding the issue of Attendance of Students in Online Lectures. All the SIC members are requested to encourage their classmates to join lectures and keep learning.

The reason discussed was Fatigue and the frustration of students due to online mode, Director sir also told all to find the solution for this and discussion will be on for this issue in upcoming meets.

9) The fees have been reduced by nearly 16000 kindly check and after that pay the remaining fees. The SBI collect doesn't have an option for Second Installment, it will be soon added and informed till that time wait for paying fees. (Fees can be paid throughout December: Second Installment)

10) The Students are allowed to do Internships till the online lectures are conducted. (After that official permissions and other things will be required which will also depend on the Academic Calendar)
